This publication is for skill levels (SLs) 3 and 4 Soldiers holding military occupational specialty (MOS) 92Y. It contains standardized training objectives, in the form of task summaries that you can use to train and evaluate yourself on critical tasks that support unit missions during peacetime and wartime. Soldiers holding MOS 92Y and SL 3 and 4 should have access to this publication. It should be made available in work areas, unit learning centers, and installation MOS libraries.

All tasks in this publication are trained to peacetime/wartime conditions and apply to the Active Army, the Army National Guard/Army National Guard of the United States, and the US Army Reserve unless otherwise stated.

Chapter 1

Introduction

1-1. <u>General</u>. This Soldier Training Publication (STP) identifies individual MOS training requirements for Soldiers holding MOS 92Y. Commanders, trainers, and Soldiers should use it to plan, conduct, and evaluate individual training in units. The STP is the primary MOS reference for supporting self-development, evaluating MOS proficiency, and training of 92Y Soldiers. Commanders employ two primary methods to evaluate Soldiers' proficiency:

- Commander's evaluation. Commander's evaluations are local tests or assessments of Soldiers' performance of MOS-specific and common tasks critical to the unit mission. They may be conducted year-round.
- Common task test (CTT). CTTs are hands-on tests used to evaluate proficiency on common tasks. Alternate written tests are provided if equipment is not available for hands-on testing.

This publication is the Soldier's primary reference to prepare for a commander's evaluation of MOSspecific tasks. It contains task summaries for all critical tasks specific to the MOS and skill level (SL). Commanders and trainers will use this Soldier's Manual/Trainer's Guide (SM/TG) to plan and conduct training and commander's evaluations.

Chapter 2, Trainer's Guide, contains information needed to plan training requirements for this MOS. The trainer's guide

- Identifies subject areas in which Soldiers must be trained.
- Identifies critical tasks for each subject area.
- Specifies where Soldiers are initially trained on each task.
- Recommends how often each task should be trained to sustain proficiency.
- Recommends a strategy for cross-training Soldiers.
- Recommends a strategy for training Soldiers to perform higher-level tasks.

Use this STP along with STP 21-1-SMCT (Soldier's Manual of Common Tasks, Skill Level 1), STP 21-24-SMCT (Soldier's Manual of Common Tasks (SMCT) Warrior Leader Skill Levels 2-4), Army training and evaluation programs (ARTEPs), FM 25-4 (How to Conduct Training Exercises), FM 25-5 (Training for Mobilization and War), FM 7-0 (Training the Force), and FM 7-1 (Battle Focused Training) to establish effective training plans and programs that integrate Soldier, leader, and collective tasks.

1-2. <u>Task Summaries</u>. Task summaries outline wartime performance requirements for each critical task in the STP. They provide both Soldier and trainer with the information necessary to prepare, conduct, and evaluate critical task training. As a minimum, task summaries include information Soldiers must know and skills they must perform to standard for each task. Following is the task summary format:

- Task number. The task number is a 10-digit number that identifies the task and skill level. Include the task number and title in any correspondence relating to the task.
- Task title. The task title identifies the action to be performed.

• Conditions. The task conditions statement describes the field or garrison conditions under which the task will be performed and identifies the equipment, tools, references, job aids, and supporting personnel that the Soldier needs to perform the task in wartime.

• Standards. The task standards describe how well and to what level of proficiency the Soldier must perform the task under wartime conditions. Standards are typically expressed in terms of accuracy, completeness, duration, sequence, speed, and tolerance.

• Performance steps. This section provides, in detail, what is required on how to perform the task.

• Performance measures. This section identifies specific actions that the Soldier must accomplish to complete the task successfully. Performance measures appear in a GO/NO-GO rating format for easy evaluation. Some tasks may also include detailed training information in a Training Information Outline and an Evaluation Preparation Section. The Evaluation Preparation Section indicates necessary modifications to task performance in order to train and evaluate a task that cannot be trained to the wartime standard under wartime conditions. It may also include special training and evaluation preparation instructions to accommodate these modifications and any instructions that should be given to the Soldier before evaluation.

• References. This section identifies references that provide more detailed explanations of task performance requirements than are given in the task summary.

• Warnings. Warnings alert users to the possibility of immediate personal injury or equipment damage.

• Notes. Notes provide additional supportive explanations or tips relating to task performance.

1-3. <u>Soldier's Responsibilities</u>. Each Soldier is responsible for performing individual tasks identified by the first-line supervisor based on the unit's Mission Essential Task List (METL). Soldiers must perform tasks to the standards included in the task summary. If Soldiers have questions about tasks or which tasks in this manual they must perform, they are responsible for asking their first-line supervisor for clarification. First-line supervisors know how to perform each task or can direct Soldiers to appropriate training materials, including current field manuals, technical manuals, and Army regulations. Soldiers are responsible for using these materials to maintain performance. They are also responsible for maintaining performance of all common tasks listed in the SMCTs at their current skill level and below. Periodically, Soldiers should ask their supervisor or another Soldier to check their performance to ensure that they can perform the tasks.

1-4. <u>NCO Self-Development and the STP</u>. Self-development is a key component of leader development. Leaders follow planned, progressive, sequential self-development programs developed by the individual NCO and his or her first-line supervisor to enhance and sustain military competencies. Selfdevelopment consists of individual study, research, professional reading, practice, and self-assessment. The self-development concept requires all NCO, as Army professionals, to take responsibility for remaining current in all phases of their MOS. The STP is the NCO primary source for maintaining MOS proficiency. Another important resource for self-development is the Army Correspondence Course Program (ACCP). For enrollment information in this program, visit on line through the Army Institute for Professional Development (AIPD) website at <u>http://www.atsc.army.mil/accp/aipdnew.asp</u>. 1-5. <u>Commander's Responsibilities</u>. Commanders must ensure that their unit training plans prepare the unit for war by enabling Soldiers to develop and sustain proficiency in their MOS and skill level tasks. Commanders should design unit training programs to provide individual training for all Soldiers assigned to the unit and to evaluate Soldier proficiency routinely as part of the commander's evaluation program. The unit training program should also integrate individual training with crew drills and other collective training. The MOS training plan provides information on which to base integration, cross-train, train-up, and sustainment training programs. Commanders should use the MOS training plan when developing unit training plans.

1-6. <u>Trainer's Responsibilities</u>. Training is the business of all unit leaders. First-line leaders are the principal trainers in the unit because they directly supervise Soldiers and lead crews, squads, sections, and teams.

a. Trainers can use the MOS training plan to determine the critical tasks each Soldier is responsible for. They should tell each Soldier which tasks he or she must be able to perform. Trainers should evaluate task performance to determine which tasks each Soldier can or cannot perform to standard. Soldiers who cannot perform a task to standard need further training. Developing effective training is explained in detail in FM 7-0 and FM 7-1.

b. Every task summary in this STP includes performance measures, which trainers may use year-round to determine if Soldiers can perform critical tasks to the specified standards. The performance measures identify what the trainer needs to observe to score a Soldier's performance. A blank space is provided for the trainer to check either the GO or NO-GO column for each performance measure. Some tasks require the trainer to watch the Soldier perform them (evaluate the process). Other tasks call for the trainer to focus on the results of the Soldier's performance (evaluate the product). Comments should not be written on the task summary.

c. Trainers can monitor the progress of their Soldiers by recording task GO/NO-GO results. Trainers may use DA Form 5164-R (Hands-On Evaluation) to record the performance measures a Soldier passed or failed. The form, which may be locally reproduced, applies to all tasks in this STP. Trainers may have DA Form 5164-R overprinted with information unique to their training requirements before reproducing it. See Appendix A for instructions on how to obtain and fill out a copy of a DA Form 5164-R.

d. Trainers may use DA Form 5165-R (Field Expedient Squad Book) to record hands-on GO/NO-GO results for a group of Soldiers (for example, a crew, section, or squad) having the same MOS and skill level. This form supports conduct of commander's evaluations and can be used to record training results gathered in the field during slack time for all MOSs and skill levels. Use of this form is optional. See Appendix B for instructions on how to obtain and fill out a copy of a DA Form 5165-R. Trainers should work with each Soldier until tasks can be performed to specific task summary standards.

1-7. <u>Training Support</u>. References have been identified for each task to assist in planning and conducting training. A consolidated list of references identified by type, publication number, and title and a comprehensive glossary of acronyms, abbreviations, and definitions are included in this STP.

Chapter 2

Training Guide

2-1. <u>General</u>. The MOS Training Plan identifies the essential components of a unit training plan for individual training. Units have different training needs and requirements based on differences in environment, location, equipment, dispersion, and similar factors. Therefore, the MOS Training Plan should be used as a guide for conducting unit training and not a rigid standard. The MOS Training Plan consists of two parts. Each part is designed to assist the commander in preparing a unit training plan which satisfies integration, cross training, training up, and sustainment training requirements for Soldiers in this MOS.

- Part One of the MOS Training Plan shows the relationship of an MOS skill level between duty position and critical tasks. These critical tasks are grouped by task commonality into subject areas.
- Section I lists subject area numbers and titles used throughout the MOS Training Plan. These subject areas are used to define the training requirements for each duty position within an MOS.
- Section II identifies the total training requirement for each duty position within an MOS and provides a recommendation for cross training and train-up/merger training.
 - **Duty Position Column**. This column lists the duty positions of the MOS, by skill level, which have different training requirements.
 - **Subject Area Column**. This column lists, by numerical key (see Section I), the subject areas a Soldier must be proficient in to perform in that duty position.
 - **Cross-Train Column**. This column lists the recommended duty position for which Soldiers should be cross-trained.
 - Train-Up/Merger Column. This column lists the corresponding duty position for the next higher skill level or military occupational specialty code (MOSC) the Soldier will merge into on promotion.
- Part Two lists, by general subject areas, the critical tasks to be trained in an MOS and the type of training required (resident, integration, or sustainment).
 - **Subject Area Column**. This column lists the subject area number and title in the same order as Section I, Part One of the MOS Training Plan.
 - **Task Number Column**. This column lists the task numbers for all tasks included in the subject area.
 - Title Column. This column lists the task title for each task in the subject area.
 - Training Location Column. This column identifies the training location where the task is first trained to STP standards. If the task is first trained to standard in the unit, the word "Unit" will be in this column. If the task is first trained to standard in the training base, it will identify, by brevity code (ANCOC, BNCOC, and so on), the resident course where the task was taught. Figure 2-1 contains a list of training locations and their corresponding brevity codes.

• **Sustainment Training Frequency Column**. This column indicates the recommended frequency at which the tasks should be trained to ensure Soldiers maintain task proficiency. Figure 2-2 identifies the frequency codes used in this column.

Chapter 3

MOS/Skill Level Tasks

Skill Level 3

Subject Area 1: Command Supply Discipline

Implement the Command Supply Discipline Program (CSDP) 101-92Y-3008

Conditions: Assigned as the unit supply specialist, in a field or garrison environment, with the requirement to implement the CSDP. Given AR 710-2 (Supply Policy Below the National Level), AR 735-5 (Policies and Procedures for Property Accountability), FM 10-27-4 (Organizational Supply for Unit Leaders), Property Book Unit Supply Enhanced (PBUSE) Commander's Guide, and local standing operating procedures (SOPs).

Standards: Develop, implement, and maintain supervisor level CSDP in accordance with AR 710-2 and AR 735-5.

- 1. Initiate CSDP. (Reference: AR 710-2, Appendix B-1 and AR 735-5, Chapter 11, paragraph 11-1) a. Define CSDP.
 - (1) A compilation of existing regulatory requirements.
 - (2) A mandatory program.
 - (3) A program designed to simplify command, supervisory, and managerial responsibilities.
 - b. Develop CSDP to implement in unit.
 - (1) Provide the personal interest and direction necessary to establish an effective CSDP.
 - (2) Identify the appropriate CSDP requirements listing from AR 710-2, Appendix B for use.
 - (3) Review the requirements listing within the CSDP in order to become familiar with applicable regulatory requirements.
 - (4) Make additions to the requirements listing for the unit's uniqueness.
 - (5) Incorporate local SOP requirements into the CSDP.
 - c. Obtain parent level inspection checklists.
 - d. Obtain parent level evaluation schedule for your unit.
 - e. Report to the immediate higher headquarters any applicable requirements within the requirements listing or checklists that cannot be completed.
- 2. Execute the CSDP. Reference: AR 710-2, Appendix B, and AR 735-5 Chapter 11, paragraph 11-6)
 - a. Perform routine duties utilizing the CSDP.
 - b. Review past evaluations conducted by higher headquarters to determine if any discrepancies have not been corrected.
 - c. Perform general regulatory requirements.
 - d. Check property authorization documents.
 - e. Check requesting and receiving supplies.
 - f. Check disposition of property.
 - g. Check property responsibility.
 - h. Check organizational clothing and individual equipment (OCIE) and personal clothing.
 - i. Check management of loads.
 - j. Check prescribed load list (PLL).
 - k. Check inventories.
 - I. Check adjustments for lost, damaged, or destroyed property.
 - m. Check storage.
 - n. Check petroleum management.

- o. Perform Property Book Unit Supply Enhanced (PBUSE) checks:
 - (1) Post the proper item authorization documents to the property master file.
 - (2) Add the sets, kits, and outfits (SKO) to the master component file.
 - (3) Post the equipment publication data to the asset master record for equipment or tool sets.
 - (4) Establish policies and procedures for the operation of the PBUSE system.
 - (5) PBUSE Work Area:
 - (a) Locate the PBUSE equipment within the unit supply administrative work area.
 - (b) Situate each computer system near an electrical circuit that provides at least 10 amps for continued operating.
 - (c) Verify that power line filters are operational.
 - (d) Use a battery or unlimited power supply.
 - (e) Clean the computer to ensure it is free of dust, dirt, and grease.
 - (f) Verify that the vents on the computer equipment are free of blockage from book, paper, or other material.
 - (6) Maintain system operations:
 - (a) Store diskettes in protective jackets and diskette storage boxes.
 - (b) Store magnetic tapes in their protective covers.
 - (c) Load only approved programs on the computer.
 - (d) Provide a work site that protects the computer equipment from rain, dust, dirt, and so on.
 - (e) Locally procure or fabricate a rugged carrying case to transport and protect computer equipment.
 - (f) Set up adequate workstation equipment (tables, and so on) for the computer equipment.
 - (g) Employ special protective cover to keep the computer equipment free of dust & dirt.
 - (7) Maintain operating supplies:
 - (a) Maintain sufficient quantities of paper and printer ribbons.
 - (b) Maintain an adequate supply of blank diskettes.
 - (c) Maintain a sufficient amount of cleaning supplies for the tape drive, diskette drives, and system exterior.
 - (8) Maintain system security:
 - (a) Keep the unit Department of Defense Activity Address Code (DODAAC) file current.
 - (b) Designate the user groups with the associated access rights.
 - (c) Review the DODAAC and security accessed data file with the outgoing and incoming unit commanders in conjunction with the change of command.
 - (d) Secure access to the system to prevent unauthorized use.
 - (e) Obtain copies of the PBUSE Automated Information System (AIS) manual.
 - (f) Familiarize the operators with the PBUSE AIS manual.
 - (g) Familiarize the commander and designated representative with the PBUSE AIS manual.
 - (h) Limit access to just the commander and or the commander's designated representatives.
 - (i) Verify that the audit register is being used to monitor system and process accesses.
 - (9) Conduct password management:
 - (a) Verify that passwords are being updated.
 - (b) Limit assigning and controlling passwords and system access rights to the commander or the commander's designated representative.
 - (c) Randomly select passwords and ensure they are six digits in length.
 - (d) Maintain copies of user identifications (IDs) and passwords in a secure location for authorized use in emergencies.
 - (10) Perform property accountability:
 - (a) Assign a unique support indicator code (SIC) in the property origin file, for each supporting PBO.
 - (b) Establish sub-hand receipt holders (SHRHs).
 - (c) Keep sub-hand receipts current.

- (d) Assign all on-hand property to SHRHs.
- (e) Post supervisor information to the SHRH files.
- (f) Check to ensure that property items requiring serial, registration, or lot number
- accounting have the proper serial/registration number requirement code (SRRC).
- (11) Perform component hand receipt functions.
 - (a) Create a master component list (MCL) for all property items needing component hand receipts.
 - (b) Keep MCLs current.
 - (c) Flag all component shortages for replenishment.
 - (d) Print current component hand receipts and obtain signature of the responsible subhand receipt holder.
 - (e) List component serial numbers for each component hand receipt as required.
 - (f) Restrict access to the MCL to the responsible staff personnel only.
- (12) Conduct component security.
 - (a) Limit component processes to the required users only.
 - (b) Have the commander periodically review unit component records to ensure compliance with Army regulations and policies.
 - (c) Have the S4 staff periodically inspect unit component records to ensure compliance with Army regulations and practices.
- (13) Perform supply management.
 - (a) Set the Standard Army Retail Supply System (SARSS) indicator in the interface parameter for the appropriate SARSS system.
 - (b) Set the replenishment-authorized flag to "Y" for elements performing supply actions in the budget/property parameters.
 - (c) Set the objective supply capability (OSC) indicator and defense data network (DDN) data in the OSC parameters, if the unit is supported by OSC.
 - (d) Set the unit identification code (UIC) and Force Activity Designator (FAD) in the unit parameters.
 - (e) Assign the document number series for expendable and durable supply actions in the unit parameters.
 - (f) Obtain a letter from the unit commander establishing the document number series to be used by his/her unit.
 - (g) Check the letter to ensure it establishes document number series for off-line manual posting to the PBUSE document register (post/post actions).
 - (h) Set the number of days for automatic follow-up and frequency of document register purge in the unit parameters.
 - (i) Set the reportable dollar value, as designated by the commander, for expenditures of command interest in the unit parameters.
 - (j) Set the class of supply and subclass of supply for items normally used by the unit in the class/subclass parameters.
 - (k) Process requests for issue in a timely manner to correct supply shortages.
 - (I) Request shortages within budget limits.
 - (m) Process turn-ins and cancellations to correct supply excesses.
- (14) Maintain unit loads.
 - (a) Establish unit load parameters for elements desiring to maintain unit load data in the unit load parameters.
 - (b) Have the unit commander approve all unit load additions and deletions, other than operational load, prior to actions being taken to add or delete unit load records.
 - (c) Have unit load reviewed periodically by the commander to validate the accuracy of the levels.
 - (d) Inspect the unit load periodically for serviceability and shelf life.
- (15) Maintain document control register.
 - (a) Post off-line manual supply actions to the system document register.
 - (b) Process supply transactions to the source of supply (SOS) daily or as required.

- (c) Obtain the unit status from the SOS for each direct support unit (DSU) and process it daily.
- (d) Research and take appropriate action for each document listed on the Supply Status Process Report.
- (16) Perform supply support requirements.
 - (a) Set the DSU code in the supply support parameters for each class of supplies authorized to be requested.
 - (b) Set the DSU unit data in the support activity site parameters, for each of the DSUs providing supply support.
 - (c) Limit security accesses to the parameter processes to the commander or commander's designated representative.
 - (d) Have the commander periodically review unit supply actions to ensure compliance with Army regulations and policies.
 - (e) Have the S4 staff periodically inspect unit supply actions to ensure compliance with Army regulations and policies.
- (17) Budget management
 - (a) Have the unit commander and unit budget manager receive a briefing from the battalion budget staff officer on the budget policies, PBUSE budget structure, and PBUSE standing operating procedures for the budget processes.
 - (b) Comply with battalion/brigade budget policies and standards.
 - (c) Obtain the budget account codes (BACs), budget ledgers or sub ledgers and fund ceilings for tracking all elements of the operating budget from battalion or brigade budget staff officer.
 - (d) Maintain the last budget data diskette received from the battalion or brigade PBUSE system.
 - (e) Have the unit commander allocate funds to each budget quarter, for all quarterly ledgers
 - (f) Distribute the total allocated amount for each ledger or sub ledger so that it is less than or equal to the total received amount.
 - (g) Establish an identity record for the unit and Unit Level Logistics System-Ground (ULLS-G)/Unit Level Logistics System-Aviation (ULLS-A) for receiving Class IX supply request data for posting to the budget.
 - (h) Have the unit commander post automated supply data and manual data to the ledger or sub ledger daily. This includes supply request data from the PBUSE supply process and supply data received from the ULLS-G/A users.
 - (i) Check the fund status of each ledger or sub ledger on a weekly basis.
 - (j) Inform the battalion or brigade budget officer when the allocated amount exceeds the received amount.
 - (k) Inform the battalion or brigade budget officer when the committed amount exceeds the allocated amount and the obligated amount exceeds the committed amount.
 - (I) Produce and use the budget reports to manage budget status.
 - (m) Report the status of ledgers or sub ledgers on a regular basis to the battalion or brigade budget officer.
 - (n) Purge closed budget ledgers/files no longer needed on the budget files to a printout report.
- (18) Manage the Army Material Status System (AMSS).
 - (a) Provide the battalion/brigade S4 with your unit's AMSS UIC.
 - (b) Complete the AMSS reporting UIC entry in the unit supply parameters screen to ensure reports can be sent to higher headquarters.
- (19) Provide the Battalion/Brigade S4 staff section with the initial/update equipment build data file for logistics support planning.
- p. Inform commander of areas that need additional command guidance, support or influence.
- q. Request assistance from higher headquarters for areas that need improvement or clarification.

- 3. Maintain the CSDP. (Reference: AR 710-2, Appendix B and AR 735-5, Chapter 11, paragraphs 11-1 through 11-6)
 - a. Develop measures to enforce supply discipline.
 - (1) Continue command emphasis on supply discipline by unit leadership.
 - (2) Provide training to unit personnel on supply requirements, procedures, and methods.
 - (3) Take administrative measures for accounting for lost, damaged, and destroyed property.
 - (4) Take disciplinary measures to deter and/or correct fraud, waste, negligent damage and/or loss of government property.
 - b. Update SOPs and CSDP to align with changing unit requirements.
 - c. Submit systemic problems that cannot be resolved to the commander for resolution.

Given property records; blank forms (such as DA Form 2062 (Hand Receipt/Annex Number), hand receipts; DA Form 3161 (Request for Issue or Turn-in), DA Form 2765-1 (Request for Issue or Turn in), DA Form 4949 (Administrative Adjustment Report), DD Form 200 (Financial Liability Investigation of Property Loss), DA Form 7531 (Checklist and Tracking Document for Financial Liability Investigations of Property Loss), DD Form 362 (Statement of Charges/Cash Collection Voucher), appropriate supply publications, AR 25-400-2 (The Army Record Information Management System (ARIMS)), AR 190-11 (Physical Security of Weapons, Ammunition, and Explosives), AR 710-2 (Supply Policy Below the National Level), AR 735-5 (Policies and Procedures for Property Accountability), DA Pamphlet 25-30 (Consolidated Index Army Publications and Forms), DA Pamphlet 710-2-1 (Using Unit Supply System (Manual Procedures)), Property Book Unit Supply Enhanced (PBUSE) system, with forms program.

Standards: Supervise unit supply operations and maintain 100 percent property accountability.

- 1. Determine the requirements to manage property administration. (Reference: AR 710-2, Chapter 1)
 - a. Follow the guidance to manage property administration in units in accordance with AR 710-2, Chapter 1, paragraphs 1-7, 1-9, and 1-28.
 - (1) Requests through command channels when regulatory guidance is not clear.
 - (2) Process deviation for supply policy requiring HQDA approval through command channels to HQDA (DALO-SMP), Washington D.C. 20310-0500.
 - (3) Identify and report supply constraints to higher headquarters that impact on compliance.
 - (4) Implement the Hazardous Materials Management Program.
 - b. Follow administrative procedures as outlined in DA Pamphlet 710-2-1, Chapter 1, paragraphs 1-4 and 1-7 and local SOP to manage property administration.
- 2. Establish property administration in a unit. (Reference: DA Pamphlet 710-2-1, Chapters 1 through 8).
 - a. Supervise personnel performing property book property authorization documents.
 - (1) Verify all pertinent property authorization documents (MTOE, TDA, and so on) are on hand.
 - (2) Verify all items that require property book accounting are on property book.
 - (3) Reconcile hand receipt with authorization allowances.
 - (4) Ensure the property book is to account for organization and installation property separately.
 - (5) Verify the PBO is appointed by commander or head of separate activity for whom the property book is maintained.
 - b. Supervise personnel maintaining the automated property listings.
 - (1) Verify the automated PBUSE Hand Receipt is on hand to show acceptance of and responsibility for assigned property.
 - (2) Verify the hand receipt accuracy.
 - (3) Provide assistance to commander to conduct required inventories by verifying accuracy of listings.
 - (4) Verify the preparation and maintenance of hand receipt procedures.

c. Supervise personnel preparing and maintaining the hand receipts procedures.

(1) Verify that sub hand receipt holders accept direct responsibility for property by signing a hand receipt.

NOTE: Verify that property provided to contractors is properly accounted for. (Reference: AR 735-5, Chapter 2, paragraph 2-5)

- (2) Verify that equipment is issued on hand receipt/sub hand receipt.
- (3) Verify change documents are posted to hand/sub hand receipt at least six (6) months from the oldest change document.
- (4) Verify temporary hand receipt property is issues for less that 30 calendar days.
- (5) Verify property issued for more than 30 calendar days are issued on a permanent hand receipt.
- (6) Verify inventory listings are used when assigning individual responsibility is not practical.
- (7) Verify that components of sets, kits, and outfits (SKO) are controlled.
- (8) Verify hand receipt shortage annexes are prepared when component shortages exist.
- (9) Verify hand receipts are filed in appropriate unit supply files.
- d. Supervise personnel requesting and receiving supplies and logistical services.
 - (1) Verify that all authorized property and components and basic loads are on hand or on request.
 - (2) Verify commander or designated representative review all requests having an Urgency of Need designator "A" and "B" for priority abuse.
 - (3) Verify the use of End Item Codes (EICs) for requesting repair parts.
 - (4) Verify that request for recoverables are preceded by a turn-in of an unserviceable like item.
 - (5) Verify the establishment and maintenance of document registers within the unit.
 - (6) Verify controls are in place to account for all VISA Government Purchase Card (GPC) purchases.
 - (7) Monitor command requirements when a unit member is appointed as an ordering/contracting officer.
 - (8) Verify requests for DRMO property are processed through Supply Support Activity (SSA).
 - (9) Verify that Delegation of Authority documents are prepared to receipt for supplies and equipment.
 - (10) Report all discrepancies when supplies and equipment are received.
 - (11) Verify that document modifiers are submitted when a change is required.
 - (12) Verify cancellation requests are submitted when requested items are no longer needed.
 - (13) Monitor the hazardous material program and provide guidance on the availability of materials.
- e. Supervise supply personnel in issuing, storing, turning in supplies and equipment.
 - (1) Issuing:
 - (a) Verify all property is issued and hand receipt accountability is maintained.
 - (b) Verify hand receipts are used whenever property book or durable items are issued.(2) Storage:
 - (a) Verify that adequate facilities and space is available for hand receipt holders to store the different classes of supplies.
 - (b) Verify that storage facilities meet physical security requirements to prevent loss.
 - (c) Verify that storage facilities meet the Occupational Safety and Health Administration (OSHA) Guidelines and local SOP.
 - (d) Verify that adequate material handling equipment (MHE) is on hand.
 - (e) Verify that storage facilities are properly marked with appropriate identifying symbols.
 - (f) Verify that materials are inspected and kept ready for use.
 - (3) Turn-Ins:
 - (a) Verify that transferred property meets accountability and maintenance requirements.
 - (b) Verify turn-in action of excess property and associated components are initiated within 10 days after the time the item is determined to be excess or un serviceable.

- (c) Verify turn-in of unserviceable and not repairable property book items through the property book officer (PBO).
- (d) Verify turn-in of unserviceable Communication Security (COMSEC) equipment is handled by the custodian.
- (e) Verify turn-in of unserviceable repairable items to supporting SSA.
- (f) Validate component shortages of property being turn-in.
- (g) Items "Found on Installation" that are not on accountable records must be turned in through PBO.
- (h) Verify turn-in of residue and unexpended ammunition after completion of training.
- (i) Verify ammunition that is found is turned in to the amnesty program.
- (j) Verify excess hazardous materials are turn-in to the SSA.
- f. Establish and maintain document registers.

 - (a) Verify PBO has designated, by Informal Memorandum, those elements authorized to request expendable and durable supplies.
 - (b) Verify the unit has an Informal Memorandum that specifies the class of supply, DODAAC, and block of document serial numbers to be used on hand.
 - (c) Verify document registers are prepared and maintained correctly.
 - (d) Verify supply status, status cards and/or listings are maintained for supplies due in.
 - (e) Verify all transactions (such as cancellation, follow-up, modification, and receipt data) are posted to document register.
 - (f) Verify document register is closed out and filed correctly.
 - (2) Automated:
 - (a) Verify PBO has designated, by Informal Memorandum those elements authorized to request expendable and durable supplies.
 - (b) Verify the unit has an Informal Memorandum that specifies the class of supply, DODAAC, and block of document serial numbers to be used on hand.
 - (c) Verify Document Number Parameter is set for classes of supply.
 - (d) Verify active and inactive document/transaction history listings are maintained correctly.
- g. Conduct reconciliation procedures with Supply Support Activity.
 - (1) Verify reconciliation is accomplished on a monthly basis or in accordance with local Standing Operating Procedures.
 - (2) Verify a copy of reconciliation is on file.
- h. Direct establishing supply and equipment inventory control function.
 - (1) Verify elements that impact on acquisition, allocation and disposal of material.
 - (2) Verify a joint change of primary hand receipt holder was conducted.
 - (3) Verify all unit property is inventoried annually.
 - (4) Verify that an inventory is conducted prior to receipt or turn-in of property.
 - (5) Verify a change of custody of arms storage facility is conducted with the results recorded on a hand receipt.
 - (6) Verify sensitive item inventories are conducted and recorded.
 - (7) Verify weapons and ammunition inventories are conducted and recorded.
 - (8) Verify unit basic and operational loads are inventoried to verify authorized stockage levels.
 - (9) Verify authorized stockage of the prescribed load list (PLL) is on hand or on request.
 - (10) Verify inventories of OCIE is conducted:
 - (a) Soldiers departing or newly assigned.
 - (b) Soldiers placed on AWOL status, hospitalized, or emergency leave.
 - (c) Soldiers returning from a field exercise.
- i. Establish and maintain supply files.
 - (1) Verify unit files are on hand and maintained.
 - (2) Verify files are disposed of when required.
- j. Supervise unit budget operations.
 - (1) Review the unit's budget requirements.
 - (2) Verify the units Annual Fund Program allocations.

- (3) Verify the commitment totals for each Element of Resources (EOR).
- (4) Verify the obligated commitment total for each EOR.
- (5) Verify the Unfinanced Requirements List.
- k. Supervise PBUSE.
 - (1) Verify that qualified individuals are available to operate the Property Book Unit Supply Enhanced Module (PBUSE).
 - (2) Verify that the PBUSE EM is on hand.
 - (3) Verify that security accesses for PBUSE have been established.
 - (4) Verify that PBUSE Parameter Files are established.
 - (5) Verify that property origin records have been established.
 - (6) Verify that Continuity of Operations Plan (COOP) for PBUSE is being performed.
- 3. Maintain property administration in a unit by applying the Command Supply Discipline Program procedures. (Reference: AR 710-2, Appendix B and AR 735-5, Chapter 11, paragraph 11-1)
 - a. Administrative action:
 - (1) Review the last evaluation to determine if past discrepancies were resolved.
 - (2) Establish suspense dates for corrective actions.
 - (3) Correct all finding using regulatory guidance.
 - (4) Brief commander on the finding at the completion of the evaluation.
 - (5) Evaluate the supply operations by using Command Inspection Checklist.
 - (6) Determine if any discrepancies are repeat findings.

 - b. Identify all Budget Allocation Records:
 - (1) Self-Service Supply Center Account.
 - (2) VISA Government Purchase Cards (GPCs).
 - (3) Morale, Welfare, and Recreation (MWR).
 - (4) Class III bulk.
 - (5) Class IX account.
 - c. Review prior year's annual funding program.
 - d. Collect data that supports developing an "Unconstrained" budget.
 - (1) Establish operational requirements affecting readiness.
 - (a) Review training missions with the S-3 to determine the impact on prior year's budget.
 - (b) Review training missions with the S-3 to determine the impact on developing budget requirements.
 - (2) Review all outstanding due-ins and cancellations that may impact on budget requirements.
 - (3) Review force structure requirements (for example, MTOE Change) which may effect the budget.
 - (4) Consider statutory requirements (compliance with federal, other laws, or Army Regulations) impacting budget requirements.
 - e. Consolidate total budget requirements.
 - f. Compare total budget requirements with the Command Operating Budget Guidance.
 - g. Provide recommendation to commander for final action.
 - h. Review the Unfinanced Requirement (UFR) list.
 - i. Forward the unit's consolidated budget requirements in accordance with Command Operating Budget Guidance.
 - j. File copy of budget requirements in the appropriate unit supply files.
- 2. Manage the budget process. (Reference: PBUSE EM).
 - a. Identify funding levels provided for each Budget Account Record.
 - b. Establish budget management systems/procedures for each account.
 - c. Supervise the processing of budget records using manual procedures.
 - (1) Verify expenditures are recorded in the remarks column of the document register when register is used to track funds.
 - (2) Verify expenditures are posted to an informal ledger or locally produced forms.
 - (a) Check to see if expenditures are posted.
 - (b) Verify the balance of allocations.
 - (3) Review budget reports that are provided by the local financial management system (for example, Standard Finance System (STANFINS) printouts and so on).
 - (4) Provide commander current budget status.
 - (5) File budget reports in accordance with local SOP.

- 3. Manage the processing of budget records using PBUSE EM. (Reference: PBUSE EM, Section 5) a. Create Standard Accounts in accordance with PBUSE EM, Section 5.6.3.1.
 - From the PBUSE-Module Main Menu, Administration, select Budget Functionality to display the Global Combat Support System (GCSS).
 - (2) Under the Accounts section, select the Create Standard Account selection; click the Create Std Accts to display the Create Standard Accounts screen.

NOTE: If a Standard account has already been created, the screen will display the message, "Standard accounts have already been created for this UIC. Please select another UIC".

(3) Click the find UIC button to display the UIC search screen. Type the desired UIC (1 to 6 positions) and click the appropriate underscored UIC display the unit information.

- a. Click Create User Accts to display the Create User Account screen.
- b. Click the find UIC button to display the UIC search screen. Type the desired UIC
- (1 to 6 positions) and click the appropriate underscored UIC display the unit information.

NOTE: For example, if "W1HDA" is entered, each UIC(s) that contains "W1HDA" is displayed.

- c. Click the Authorized by LOV and make a selection.
- d. Type the name of the account in the Account Name field.
- e. Type Description of the account in the Account Description field, if desired.

 - (9) Verify that any excess items are returned to the SOS.
 - (10) Verify that turn-in documents are filed in the unit supply files.
 - d. Review unit loads demand history. (Reference: PBUSE EM, Section 8)
 - (1) Access the PBUSE Module Main Menu.
 - (2) Click Hand Receipt.
 - (3) Click Operational/Basic load to display the Operational/Basic Load Screen.
 - (4) Click the Find button and select the DODAAC.
 - (5) Click the Load Type LOV and choose either operational or basic.
 - (6) Click the Demand Qty field of the desired NSN to display the Demand History screen.
 - (7) Click Close to exit.

- 2. Conduct follow-up to correct unit load deficiencies. (Reference: DA Pamphlet 710-2-1, Chapter 7, paragraph 7-3)

 - (c) Compute aviation gasoline (AVGAS), if required.
 - (3) Determine storage space required for Class III basic load.
 - i. Determine basic load for Class V based on unit authorization of weapons, in accordance with PBUSE Planning Table, Chapter 5, paragraph 5.7.2, page 5-137.
 - (1) Verify the unit's required and authorized quantities of weapons.
 - (2) Compute Class V based on weapon density and DOS.
 - (3) Determine storage space required for Class V basic load.

- k. Coordinate the replenishment of basic load for Classes I, II, III, IV, V, VI, and VIII (except medical repair parts) of supply.

 - (a) Enter load code to update the unit load.
 - (b) Enter NIIN of the expendable item to be added to the unit load.
 - (c) Process the NIIN to add unit load record.
 - (d) Enter authorized quantity.
 - (e) Enter replenishment quantity.
 - (f) Enter location code.
 - (g) Enter shelf life expiration date, if applicable.
 - (h) Review the entries.
 - (i) Process the record.

- 1. Review property adjustment documents for administrative and regulatory compliance. (Reference: AR 735-5, Chapter 12-13, paragraph 12-3, Figure 12-5, Chapter 13, paragraph 13-10, Figure 13-4 and DA Pamphlet 710-2-1, Chapter 4, paragraphs 4-19 through 4-26, Figure 4-13 through Figure 4-20).
 - a. Review DD Form 200 and administrative and processing procedures.
 - (1) Verify that necessary procedures take place within the time limits required.

 - (3) Verify that the initiator, appointing/approving authority, and investigating officer complete all required actions.
 - (4) Review investigating officer's findings and recommendation(s) for regulatory compliance.
 - (5) Review the Judge Advocate General's (JAG) legal review of all financial liability of property loss pertaining to financial liability.
 - (6) Process letter of notification to the individual when financial liability is approved.
 - (7) Forward a copy of the financial liability investigation of property loss to the Continuing Balance System-Expanded (CBS-X) central collection agency, if required.
 - (8) Review the financial liability investigation of property loss system during the command inspection program for regulatory compliance.
 - (9) Verify that equipment is replenished when a financial liability investigation of property loss is processed for the loss of equipment.
 - (10) Verify that financial liability investigation of property loss are filed in the appropriate unit supply file.
 - (11) Prepare a summary of all financial liability investigation of property loss to assist the appointing/approving authority in making a final decision.
 - (12) Advise appointing/approving authority of regulatory options when making "Final Approval" decision.
 - (13) Process all financial liability investigation of property loss that recommends financial liability to the JAG for legal review prior to presenting adjustment document to appointing/approving authority.
 - (14) Review requests for reconsideration for administrative and regulatory compliance prior to forwarding to the appointing/approving authority.
 - (15) Advise appointing/approving authority of regulatory options when a request for reconsideration is received.

- (16) Process requests for reconsideration denials to the appellate authority in accordance with AR 735-5, Chapter 13, paragraph 13-51.
- (17) Process appointing/approving authority notification letter to the respondent when financial liability has been assessed.
- b. Review DA Form 7531 and administrative processing procedures.
 - (1) Verify that the DA Form 7531 is attached to the DD Form 200 and used as a checklist for tracking events as they occur
 - (2) Verify that checklist and tracking document for financial liability investigations of property loss are processed in accordance with AR 735-5, Chapter 13, paragraph 13-9 and Figure 13-3.
 - (3) Verify the name of each official is placed in each individual completing blocks.
 - (4) Verify that elements in part A were completed as events occurred.
 - (5) Verify that section A through I of the DA Form 7531 was completed by the appropriate official and the appropriate official track the events as they occurred.
 - (6) Verify that DA Form 7531 is filed in the appropriate supply file.
- c. Review DA Form 4949 administrative processing procedures.
 - (1) Verify that AAR procedures for minor property book adjustments are processed in accordance with DA Pamphlet 710-2-1, Chapter 4.
 - (2) Verify that units are not using the AAR when there is a possibility of a substitution or sensitive item.
 - (3) Forward a copy of the AAR to the CBS-X central collection agency, if required.
 - (4) Review AAR processing procedures during the command inspection program.
 - (5) Verify that AARs are filed in the appropriate unit supply file.
- d. Review DD Form 362 administrative processing procedures and statement of charges/cash collection vouchers are filed in the appropriate supply file.
 - (1) Verify that DD 362s are processed in accordance with AR 735-5, Chapter 12, paragraph 12-3.
 - (2) Check to see if the subordinate units are offering individuals the opportunity to sign a DD Form 362.
 - (3) Forward a copy of statement of charges/cash collection voucher to the CBS-X central collection agency, if required.
 - (4) Review statement of charges/cash collection voucher processing procedures during the command inspection program.
 - (5) Verify that equipment is replenished when a statement of charges/cash collection voucher is processed for loss of equipment.
 - (6) Verify that statement of charges/cash collection vouchers are filed in the appropriate supply file.
- 2. Post an Administrative Adjustment Document. (Reference: PBUSE EM, Section 7.3.2)
 - a. Access the PBUSE Module main menu.
 - b. Click the Property Book menu.
 - c. Click the Administrative Adjustment Report Screen.
 - d. Click the Administrative Change Tab to display the Administrative Change screen.
 - e. Click the find button to display the Doc No Search screen.
 - f. Click the Document Number to select the document.

NOTE: If no document numbers appear, enter a complete document number in the Doc No field and click the GO button, or enter a partial document number, click the GO button, and then click the desired Document Number. The Document Number is displayed on the Administrative Changes Tab. The screen layout will vary depending upon the Adjustment Action of the document.

g. Click the First, Prev, Next, and Last buttons to navigate the list.

NOTE: While the TYPE ACTION is "S", make the appropriate changes in the applicable field and click the Apply button. To ensure changes are saved, click the apply button before clicking the First, Prev, Next, or Last button.

- h. If the adjustment action is Assembly:
 - (1) Click the insert button to display the Add New Item screen.
 - (2) Enter the request document number in the Doc No field.
 - (3) Enter the Component NSN in the NSN field and click the View button to display the item's details.
- i. If the adjustment action is Disassembly:
 - (1) Click the insert button to display the Add New Item screen.
 - (2) Enter the turn-in document number in the Doc No field.
 - (3) Enter the Component NSN, if applicable, in the NSN field and click the View button to display the item's details.
- j. If the item does not have an NSN:
 - (1) Enter the nomenclature in the Nomen field.
 - (2) Enter the Unit of Issue is applicable, in the UI field.
 - (3) Click the apply button to add the item to the document.
 - (4) Click the close button to return to the Administrative Change Tab.
 - (5) Change the Adjust Qty as necessary and click the Apply button.
- k. If the Adjustment Action is an Make/Model Change:
 - (1) Click the Insert button to display the Add New Item screen.
 - (2) Enter the ALIN if needed.
 - (3) Enter the new NSN in the NSN field and click the View button to display the item's detail.
 - (4) Click the Apply button to add the item to the document.
 - (5) Click the close button to return to the Administrative Change Tab.
 - (6) Change the Adjustment Quantity as necessary and click the Apply button.

NOTE: To remove items from the list, click the Delete check box and then click the Delete button. To ensure selections are deleted, click the Delete button before clicking the First, Prev, Next, or Last buttons.

Given AR 25-400-2 (The Army Information Management System (ARIMS)), AR 735-5 (Policies and Procedures for Property Accountability), AR 710-2 (Supply Policy Below the National Level), DA Pamphlet 710-2-1 (Using Unit Supply System Manual Procedures), DA Form 3643 (Daily Issues of Petroleum Products), DA Form 3644 (Monthly Abstract of Issues of Petroleum Products and Operating Supplies), DA Form 2064 (Document Register for Supply Actions), DA Form 3853-1 (Innage Gage Sheet [Using Innage Tape and BOB]), DA Form 4702-R (Monthly Bulk Petroleum Accounting Summary (MBPAS)), local standing operating procedures (SOPs), local forms program, and a computer.

Standards: Maintain 100 percent accountability for bulk petroleum products in accordance with DA Pamphlet 710-2-1 and local SOP.

- 1. Maintain audit trails on all fuel issued and received. (Reference: DA Pamphlet 710-2-1, Chapter 12, paragraph 12-14)
 - a. Post all fuel received as a receipt, except fuel issued by the SSA directly into or specifically identifiable to a consuming end item of equipment.
 - b. Prepare a memorandum for the responsible individual.
 - (1) Enter name.
 - (2) Enter rank.
 - (3) Enter signature of responsible individual.
 - (4) Enter duty appointment.
 - (5) Enter signature block of approving authority.
 - (6) Enter signature of approving authority.
 - c. Maintain DA Form 3643.
 - (1) Verify that daily issue of petroleum products is used by the dispensing facility as a daily record of issue to vehicles or other petroleum consuming items of equipment.
 - (2) Make sure that this form is turned in to the accountable officer at the end of each day and it is then checked to ensure that the following items are complete:
 - (a) Vehicle registration number.
 - (b) Type, grade, and unit of issue for each product issued to one vehicle.
 - (c) Organization and address of the unit receiving the bulk petroleum.
 - (d) Signature and grade of the person receiving bulk petroleum.
 - (e) The post where the fuel is being issued.
 - (f) The date block.
 - (g) Signature of the attendant.
 - d. Maintain a statement of summarized daily issues.
 - (1) During a field exercise, if maintaining auditable records is not feasible, the unit commander will prepare a statement of summarized daily issues.
 - (2) Inventories are taken and documented on a daily basis to determine the amount of fuel issued.
 - (3) The opening inventory, plus receipts, minus the closing inventory is the amount of fuel issued that day.
 - (4) Indicate that the fuel was used in authorized army equipment.
 - (5) Complete the statement within three working days after completion of exercise.
 - (6) Post quantities to DA Form 3644 as of the last day of the exercise.
 - (7) File and maintain the statement as a supporting document to the DA Form 3644.
 - (8) Statement does not replace audit trail, but supplements auditable record.

- (9) Verify that this statement contains the following information:
 - (a) Enter dates of the exercise.
 - (b) Enter date of each issue.
 - (c) Enter unit receiving the issue.
 - (d) Enter type of fuel.
 - (e) Enter quantity.
 - (f) Enter signature block of commander.
 - (g) Enter signature of commander.
- e. Maintain DA Form 3644.
 - (1) Verify that DA Form 3644 is prepared for each month starting on the first day of each month. Use DA Form 3644 for all types of fuel (such as MOGAS, DSL, JP 8, and so on).
 - (2) Verify that quantities on DA Form 3643 used for each day are totaled and posted to the applicable line on DA Form 3644.
 - (3) Verify at the end of each month that DA Form 3644 is totaled for issues and receipts; a document number is assigned and the totals for each type/grade of bulk petroleum are posted in the supporting document file 710-2a.
- f. Maintain DA Form 2064 in accordance with DA Pamphlet 710-2-1.
 - (1) Verify that issues and receipts for bulk petroleum are recorded on the document register.
 - (2) Verify that a separate document register and block of document numbers may be assigned to bulk petroleum by the local SOP.
 - (3) Verify that all receipts for bulk petroleum that have been recorded on DA Form 2064 are placed in the document supporting file with all other documents listed on the document register.
- g. Prepare DA Form 3853-1.
 - (1) The DA Form 3853-1 is a monthly physical inventory for each type or grade of bulk fuel on hand within the unit.
 - (2) Fill in the following information on DA Form 3853-1:
 - (a) Enter unit.
 - (b) Enter date.
 - (c) Enter time.
 - (d) Enter location.
 - (e) Enter American Petroleum Institute (API) gravity.
 - (f) Enter check mark in inventory block.
 - (g) Enter tank number.
 - (h) Enter normal tank capacity.
 - (i) Enter product and grade.
 - (j) Enter tape reading: 1) Enter lineal reading. 2) Enter volume TRIC equivalent gallons.
 - (k) Enter the bob reading: 1) Enter lineal reading. 2) Enter volume TRIC equivalent gallons.
 - Enter net volume of product, uncorrected temperature (Line 1 minus line 2): 1) Leave blank. 2) Enter the total volume TRIC equivalent gallons.
 - (m) Enter average temperature: 1) Enter temperature. 2) Leave blank.
 - (n) Enter multiplier: 1) Enter multiplier number. 2) Leave blank.
 - (o) Net quantity of product at 60° F. (U.S. gallon) (line 3 is multiplied by line 5): 1) Leave blank. 2) Enter net quantity.
 - (p) Enter name and grade of operation officer.
 - (q) Enter signature of operation officer.
 - (r) Enter name and grade of gager.
 - (s) Enter signature of gager.
 - (3) This inventory is documented in the Physical Closing Inventory block on the MBPAS report.
 - (4) Place DA Form 3853-1 in the unit supply files.

h. Provide usage data for future allocation requirements.

- (1) Track usage data using DA Form 4072-R.
- (2) Develop annual requirements for next fiscal year.
- 2. Account for bulk petroleum using DA Form 4702-R. (Reference: DA Pamphlet 710-2-1, Chapter 12, paragraph 12-19)
 - a. The MBPAS contains auditable records of monthly receipts, issues, and inventory of bulk petroleum products. Additionally it is used to adjust inventories.
 - b. The MBPAS becomes the account record for petroleum products in the using unit. This form may be generated electronically if the user has the automation capability available.
 - c. Change of responsible individual requires closing of the MBPAS and starting of a new MBPAS with the new designated responsible individual signature.
 - d. Close DA Form 4702-R out as of 0800 hours local time the last day of the month.
 - e. Submit the report to the next higher headquarters within three working days of the end of the month.
 - f. Prepare DA Form 4702-R. Fill in the following information on DA Form 4702-R:
 - (1) Enter name of the post, camp, or station in the Post, Camp, or Station block.
 - (2) Enter the unit identifier code in the Property Account Number block.
 - (3) Enter the beginning date (From) and the ending date (To) in the Period of Report block.
 - (4) Enter the NSN and product nomenclature in the Products block.
 - (5) The number is the physical inventory quantity from the previous month's closing inventory book in the Opening Inventory block.
 - (6) This number is the total of the Receipt (Gals) column (including defuels) on DA Form 3644.
 - (7) This number is the total of the Issue (Gals) column on DA Form 3644.
 - (8) Calculate this balance by taking the Opening Inventory (block a), plus the total Receipts (block b), minus the total Issues (block c) in the Closing Book Balance block.
 - (9) Obtain this quantity by taking a physical inventory on DA Form 3853-1 of all bulk petroleum products on hand in the Physical Closing Inventory block.
 - (10) Obtain this figure by calculating the difference between the physical closing inventory (block e) and the closing book balance (block d). Reflect losses with a minus sign and reflect gains with a plus sign.
 - (11) Calculate the Maximum Allowable Gain/Loss of AVGAS, MOGAS, and jet fuels by adding the Opening Inventory (block a), to the Receipts (block b), and multiplying this total by .01. Place the total in the Maximum Allowable Gain/Loss block. The maximum allowable gain/loss for all other products is calculated by adding the Opening Inventory (block a), to the Receipts (block b), and multiplying the total by .005.
 - (12) Record any explanations that the accountable/responsible officer makes to clarify data in the Remarks block.
 - (13) Enter document number in the top right hand corner above the Period of Report block.
 - (14) Type or print the name of the approving authority in the Name/Grade of Approving Officer block.
 - (15) Enter signature of the approving authority in the Signature block.
 - (16) Enter the date signed by the approving authority in the Date block.
 - (17) Since most petroleum products are subject to a comparatively high evaporation rate and losses in handling due to spillage, a loss allowance has been established for certain products. To determine if there is a loss or overage, the closing inventory is subtracted from the closing book balance. This amount is entered in the monthly gain/loss block. Allowable losses are:
 - (a) Handling of bulk petroleum.
 - (b) Transportation.
 - (c) Storage.
 - (d) Weather.

- (18) Allowable losses are determined by adding the Opening Inventory block and the Receipts block and multiplying this total by a specified percentage. For gasoline, jet fuel, and JP-8, this percentage is 1 percent (.01). For kerosene, solvent, oil, diesel fuel, and fuel oil, the percentage is ½ of a percent (.005).
- (19) If the actual loss is less than the allowable loss, the actual loss is posted as a turn-in. The MBPAS is forwarded to the approving authority for signature. The approving authority has the option to approve the MBPAS or direct the initiation of a Financial Liability Investigation of Property Loss.
- (20) If the total handling loss of a specific bulk petroleum product exceeds the allowable loss for that product, and the dollar value of the total loss exceeds \$500, there is a mandatory initiation of a Financial Liability Investigation of Property Loss. The Financial Liability Investigation of Property Loss is assigned the same document number as the MBPAS. Both the Financial Liability Investigation of Property Loss and the MBPAS are forwarded to the approving authority for the appropriate action in accordance with AR 735-5.
- (21) In the unlikely event that the closing inventory quantity exceeds the closing book balance, an MBPAS is prepared under the provisions of AR 70-12, which reflects a quantity over. The quantity over is posted as a receipt. The closing book balance then agrees with the inventory quantity and is the opening inventory for the subsequent month.

Subject Area 5: Logistics System Operations

Implement Continuity of Operations Plan (COOP) 101-92Y-3101

Conditions: Assigned as unit supply specialist in a field or garrison environment and given the requirement to implement a COOP. Given a COOP plan; local standing operating procedures (SOPs); AR 500-3, AR 710-2; Property Book Unit Supply Enhanced (PBUSE) System, and a PBUSE EM.

Standards: Verify that the unit(s) supply clerk, performs the daily backup of database files and the ability to restore database and system files to a PBUSE operating system without loss of data in accordance with PBUSE End User Manual (EM) and local SOP.

- 1. Identify the requirement for a COOP. (Reference: AR 500-3, Chapter 1, paragraph 1-9)
 - a. Provide for continued performance of an organization's MEF under all circumstances.
 - b. Establish procedures governing succession to office.
 - c. Establish emergency delegations of authority.
 - d. Establish procedures for the safekeeping of vital resources, facilities, and records.
 - e. Establish procedures for the improvisation or emergency acquisition of resources necessary to execute MEF.
 - f. Establish the capability and procedures needed to relocate essential personnel to alternate locations to support MEF.
 - g. Consider assigning, training, and equipping augmentation forces to facilitate evacuation, shelter-in-place and other COOP related requirements as deemed necessary by the organization leadership.
 - h. Establish the capability to shelter-in-place essential personnel.
 - i. Establish the capability to shelter-in-place nonessential personnel. During this situation, nonessential personnel may augment essential personnel as deemed necessary by the senior Army official in charge of the facility's COOP mission.
 - j. Establish capabilities to execute MEFs at the alternate location pending reconstitution to normal operations.
 - k. Establish interoperable communication capabilities within organization, DOD components, Joint Forces, and support agencies in order of priority.
 - Require annual testing, training and/or exercising of COOP capabilities. These may be tabletop, functional, or full-scale exercises as determined by the senior Army official responsible for the organization.
 - m. Require plans to take into account and respond to threats that all personnel, the mission, and COOP are most likely to face.
 - n. Establish procedures for the devolution of command and control.
 - o. Establish plans for reconstitution and return to normal operations.
 - p. Consider issuing military personnel, civilian and contractor employees with COOP responsibilities a Government Emergency Telecommunication Service (GETS) cards.
 - q. Ensure emergency relocation facilities (ERF) comply with the Americans with Disabilities Act and be accessible and designed for handicap personnel.
 - r. Ensure ERFs and essential facilities are capable of permitting ingress as well as egress during power-out conditions.
 - s. Ensure that Department of Army Civilians (DAC) position descriptions and statements of work for contractors with COOP responsibilities clearly reflect and/or specify what their nonroutine office duties are (for example, travel, 24-hour on-call duties, 24-hour exercise duties, and so on).
 - t. Consider designations on badges or other forms of identification to distinguish the COOP or other personnel exempt from movement restrictions during a COOP event.

- u. Address contingency procurement/contracting requirements and procedures during COOP events.
- v. Declare in their procedures that their COOP OPLAN automatically becomes an OPORD upon COOP declaration/activation.
- w. Ensure that ERG and other COOP Personnel who may carry classified information outside of their normal place of duty are issued and possess current Courier Cards upon appointment to these positions.
- x. Ensure that senior military or DAC personnel, by grade, in a Government vehicle are aware that they are in charge of the vehicle, its contents and passengers.
- y. Not use hospitals, emergency care or other civilian emergency facilities for military purposes in accordance with the Geneva Convention.
- z. Ensure that at least annually, if possible, senior Army officials responsible for their organization assess and/or test their power out emergency circuitry, emergency generators, and power-out ingress and egress mechanisms during actual power-out conditions to determine emergency requirements under simulated disaster conditions.
- 2. Determine the minimum COOP plan requirements. (Reference: AR 500-3, Chapter 2)
 - a. Support COOP plans of higher headquarters and supported organizations, as applicable.
 - b. Provide capability to execute with or without warning and during duty and nonduty hours.
 - c. Provide flexibility and responsiveness to anticipate any emergency or crisis that interrupts MEF.
 - d. Establish a decision process for determining appropriate actions for implementation of COOP plans.
 - e. Identify and prioritize MEFs necessary to execute during emergencies.
 - f. Identify organizational MEFs that can be deferred without impact to the unit's core mission until the situation permits their execution.
 - g. Identify, prepare, maintain, and protect facilities and key personnel necessary to support continuity programs.
 - h. Identify essential resources, files, databases, telecommunication equipment (secure telephone units, secure telephone equipment, secure laptops, SIPRNET connections, encryption device); and ensure security classifications are appropriate at the COOP site.
 - i. Identify, train, and exercise ERG members and all continuity staff at least annually.
 - j. To ensure capability to perform MEF and to serve as basis for reconstitution, provide for leadership successors and alternates, emergency delegations of authority, decisions, and orders of succession for key positions.
 - k. Provide for alert and notification of ERG personnel, as a minimum, and identify procedures for advisories, alerts, and notifications.
 - I. Provide for personnel accountability throughout the duration of the emergency.
 - m. Provide for attaining operational capability (such as state of capability to complete all unit MEFs) within 12 hours.
 - n. Establish reliable processes and procedures to acquire resources necessary to continue MEFs and sustain operations for a minimum of 30 days.
 - o. Establish the capability to shelter-in-place essential personnel.
 - p. Establish the capability to shelter-in-place nonessential personnel. During this situation. nonessential personnel may augment essential personnel as deemed necessary by the senior Army official in charge of the organization's COOP mission.
 - q. Establish and maintain MEF application and database replication procedures.

Supervise Unit Arms Room Operations 101-92Y-3203

Conditions: Assigned as the unit supply specialist in a field or garrison environment, given the responsibility to supervise unit arms room operations. Given AR 25-400-2 (Army Information Management System (ARIMS)), AR 190-11 (Physical Security of Arms, Ammunition, and Explosives (AA&E)), AR 190-13 (The Army Physical Security Program), AR 710-2 (Supply Policy Below the National Level), DA Pamphlet 710-2-1 (Using Unit Supply System Manual Procedures), FM 5-0 (Army Planning and Orders Production), DA Form 17 (Requisition for Publications and Blank Forms), DA Form 1687 (Notice of Delegation of Authority – Receipt for Supplies), DA Form 2062 (Hand Receipt/Annex Number), DA Form 3161 (Request for Issue or Turn-In), DA Form 3749 (Equipment Receipt), DA Form 4604 (Security Construction Statement), DA Form 5513 (Key Control Register and Inventory), Sensitive Item Inventory Listing, Master Authorization List (MAL), Weapon/Ammunition Control Log, local standing operating procedures (SOPs), and a computer.

Standards: Supervise unit arms room operations while maintaining 100 percent accountability of all weapons in accordance with AR 710-2, AR 190-11, AR 190-13, DA Pamphlet 710-2-1, DA Pamphlet 750-8, and local SOP.

- 1. Review arms room procedures. (Reference: AR 190-11; AR 710-2, DA Pamphlet 710-2-1, and FM 5-0)
 - a. Review administrative and management procedures.
 - (1) Verify that sensitive pilferable items such as tools and high value items are stored in a separate area in the arms room.
 - (2) Verify that DA Form 4604 indicates highest construction category for storage of AA&E on file.
 - (3) Verify that AA&E storage buildings have interior/exterior security lighting.
 - (4) Verify that DA Form 3749 is issued for each individually assigned weapon and privately assigned weapon.
 - (5) Verify that the unit armorer maintains a MAL with all personnel authorized the issue of weapons.
 - (6) Verify that weapon/ammunition control sheets are retained in unit active files until the next monthly inventory is conducted.
 - (7) Verify that procedures are followed when changing arms room custody using DA Form 2062.
 - (8) Ensure that monthly weapons inventories are conducted by the responsible officer, commissioned officer, warrant officer (WO), noncommissioned officer (NCO), or separate Department of Defense (DOD) civilian, rather than the armorer or the same individual consecutively.
 - (9) Ensure that ammunition is inventoried by purpose (such as basic load, operational load, or training).
 - (10) Verify that AA&E storage areas are posted as restricted areas (in Host Nation language).
 - (11) Verify that the commander has given written authorization for the storage of high value, pilferable, sensitive items in the arms room.
 - (12) Verify that names and duty positions of personnel authorized unaccompanied access to the AA&E are posted inside the arms room.
 - (13) Make sure that a record of security screen checks for personnel involved in control of AA&E are on file in the arms room.
 - (14) Ensure that privately owned weapons and ammunition are locked in a container separate from military AA&E.

- (15) Ensure that applicable regulations and laws on ownership, possession, and registration of privately owned weapons and ammunition are posted on the unit bulletin board.
- (16) Ensure that the unit commander or designated representative approves withdrawal of privately owned weapons and ammunition from the arms room.
- b. Review DA Form 5513.
 - (1) Ensure that the arms room key custodian has written authorization.
 - (2) Ensure that keys to the AA&E building, rooms, containers and Intrusion Detection System (IDS) are maintained separately from other keys, accessible only to individuals whose official duties require access to them.
 - (3) Verify DA Form 5513 is being used to maintain continuous accountability of keys.
 - (4) Verify that completed DA Form 5513 is retained in unit files for a minimum period of 90 days.
 - (5) Ensure that padlocks are locked to staples or hasps when areas, arms room racks, and containers are open.
 - (6) Verify that key and lock inventory is conducted semiannually.
 - (7) Ensure that key and lock inventory is recorded and retained in unit files for one year.
- c. Review arms room SOP.
 - (1) Verify that the SOP list procedures unique to the organization.
 - (2) Ensure that the SOP:
 - (a) Consolidates actions contained in other Army publications.
 - (b) Reflects the supply system used at the installation.
 - (c) Explains change of hand receipt holder and inventory procedures.
 - (d) Establishes procedures to provide personnel with information and requisite training on handling, storage, and use of hazardous materials.
 - (e) Covers all areas of supply operations.
 - (3) Ensure that supply personnel are familiar with the SOP.
 - (4) Ensure that the unit local SOP is signed by the commander.
- 2. Review arms room hand receipt procedures. (Reference: DA Pamphlet 710-2-1, Chapter 2, paragraph 2-28 and Chapter 5, paragraphs 5-3 and 5-4)
 - a. Determine that DA Form 2062 is:
 - (1) Prepared for all non-expendable and durable property.
 - (2) Kept current.
 - (3) Maintained properly.
 - b. Verify that the Sensitive Items Inventory Listing and reports are being maintained for the appropriate time period.
 - (1) Office conducting the inspection: Destroy after 3 years.
 - (2) Office inspected: Destroy after 1 year.
 - c. Ensure that the original DA Form 2062 is kept by the issuing individual, and that the duplicate is held by the hand receipt holder.
 - d. Ensure that property, not on the hand receipt, is under the control of the property book officer.
 - e. Ensure change documents are being used.
 - f. Ensure DA Form 1687 is:
 - (1) Prepared correctly.
 - (2) Kept current.
 - g. Verify that hand receipt annexes are prepared for non-expendable/durable component shortages.
 - h. Verify that items listed on the hand receipt annexes are on order.
 - i. Verify that the initials in the quantity column of the hand receipt annexes are those of an authorized person.
 - j. Verify that hand receipt annexes are filed with the hand receipt or sub-hand receipt to which they apply.

 - (2) Verify status of weapons turned in with the direct support (DS) maintenance section.
 - (3) Verify that a current copy of DA Form 2407 for annual gauging is on file.

Chapter 4

Duty Position Tasks

92Y- Unit Supply Specialist (Unit Supply Specialist), CMF 92

Major duties. The unit supply specialist supervises or performs duties involving request, receipt, storage, issue, accountability and preservation of individual, organizational, installation and expendable supplies and equipment. Duties for MOS 92Y at skill levels 1 through 5 are:

- MOSC 92Y10. Receives, inspects, inventories, loads, unloads, segregates, stores, issues, delivers and turns in organization and installation supplies and equipment. Operates unit level computer (ULC). Prepares all unit/organizational supply documents. Maintains automated supply system for accounting of organizational and installation supplies and equipment. Issues and receives small arms. Secures and controls weapons and ammunition in security areas. Schedules and performs preventive and organizational maintenance on weapons.
- MOSC 92Y20. Performs duties shown at preceding level of skill and provides technical guidance to lower grade personnel. Inspects completed work for accuracy and compliance with established procedures. Coordinates supply activities. Reviews and annotates changes to unit material condition status report. Post transaction to organizational and installation property books and supporting transaction files. Determines method of obtaining relief from responsibility for lost, damaged, and destroyed supply items.
- **MOSC 92Y30**. Performs duties shown at preceding level of skill and provides guidance to lower grade personnel. Directs supply personnel in establishing supply and inventory control management functions. Maintain property under Standard Property Book System (SPBS). Review daily and monthly records of issues of petroleum products and operating supplies. Provide technical assistance to equipment records and parts specialist. Assists and advises supply officer and commander.
- MOSC 92Y40. Performs supervisory and management duties shown at preceding level of skill. Analyzes statistical data and reports to ascertain trends, conformance to standard and directives and efficiency of operations. Coordinate logistical activities with other staff elements supply and service and motor transport units. Conducts assistance visits to subordinate elements. Develops and executes training programs.
- MOSC 92Y50. Supervises development and preparation of operations information, plans, maps, sketches, overlays and related data to employ supply and service organizations. Contributes to staff development and operations of supply support data systems, equipment review, salvage and repair parts supply procedures. Perform liaison between staff and supported personnel to improve effectiveness of support activities. Conducts inspections and provides technical assistance to the Inspector General.

FIELD EXPEDIENT SQUAD BOOK (DA FORM 5165-R) INSTRUCTIONS

DA Form 5165-R (Field Expedient Squad Book) allows the trainer to keep a record of task proficiency for a group of Soldiers.

Before evaluation:

- 1. Obtain a blank copy of <u>DA Form 5165-R</u>, which you may locally reproduce on 8 ½ x 11 paper.
- 2. Locally reproduce the partially completed form if you are evaluating more than nine Soldiers.

During evaluation:

- 1. Enter the names of the Soldiers you are evaluating, one name per column, at the top of the form.
- 2. Under STATUS, record (in pencil) the date in the GO block if the Soldier demonstrated task proficiency to SM standards. Keep this information current by always recording the most recent date on which the Soldier demonstrated task proficiency. Record the date in the NO-GO block if the Soldier failed to demonstrate task proficiency to SM standards. Soldiers who failed to perform the task should be retrained and reevaluated until they can meet the standards. When the standards are met, enter the date in the appropriate GO block and erase the previous entry from the NO-GO block.

After evaluation:

- 1. Read down each column (GO/NO-GO) to determine the training status of an individual. This will give you a quick indication of which tasks a Soldier needs training on.
- 2. Read across the rows for each task to determine the training status of all Soldiers. You can readily see which tasks to focus training on.
- 3. Line through the STATUS column of any Soldier who leaves the unit.

Section II. Terms

authenticate

To establish or prove that facts or documents are valid, true, or genuine.

authority

An action that gives official power to a service member.

basic load

Quantity of conventional ammunition that is authorized and required to be on hand within a unit or formation at all times.

cancellation

A way to void a supply request that is no longer needed.

change document

A form used to issue and turn in transactions between the property book officer and hand-receipt holder. It is also used between the hand-receipt holder and subhand-receipt holder.

component hand receipt

A list of nonexpendable and durable components of sets, kits, and outfits that have been issued to an individual for use.

condition code

A one-position, alphabetical character used to classify materiel (ammunition). Condition codes identify the degree of serviceability, the condition, and the completeness of ammunition in terms of readiness for issue and use. They also can be used to identify actions under way to change the status of materiel.

Continuing Balance System-Expanded

A system that maintains Armywide Reportable Item Control Code 2 equipment balances by line item number/national stock number identified to the UIC level. This system provides accurate, timely, and auditable Armywide equipment data that can be used for procurement, distribution, and redistribution decisions.

DA Form 2064 (Document Register)

A form used to record all supply transactions that require a document number.

DA Form 3078 (Personal Clothing Request)

A form used to request personal military clothing for enlisted personnel.

Disposal

The act of getting rid of records, documents, and excess, obsolete, or surplus property under proper authority. Disposal may be accomplished by, but is not limited to, transfer, donation, sale, or abandonment, but does not include redistribution.

Disposition

The final settlement of a supply matter.

Dunnage

Any material on which supplies are stored; for example, boards, planks, blocks, or metal bracing.

Durable item

An item which is not consumed in use, is not classified as nonexpendable or expendable, and keeps its identity such as hand tools.

End item

Nonexpendable item of equipment or property that consists of more than one component (for example, a truck).

Established delivery date

The date a unit can expect to receive an item.

Expendable item

An item consumed in use or that loses its identity (such as paint, cleaning materials, office supplies).

Follow-up

A document used to request status on open or incomplete supply requests. This request is sent to the SSA.

Gaining unit

The unit receiving property on a lateral transfer.

Hand and subhand-receipt

A document used to record acceptance of and responsibility for durable and nonexpendable items issued to an individual.

Hand-receipt annex

A document used to record overages and shortages of components of major end items and of chests, sets, kits, and outfits.

Key control register

A document used to ensure administrative accountability for keys.

Lateral transfer

The permanent transfer of supplies or equipment from one unit to another unit. Supplies or equipment are transferred using DA Form 3161 (Request for Issue or Turn-In).

Maintenance category

The level of maintenance to be applied; for example, 0 for organizational maintenance; C for operator/crew; F for direct support maintenance; H for general support maintenance; D for depot maintenance.

malfunction

Failure of an item to function in accordance with the its expected performance or functioning of the explosive components during a nonfunctional test. A critical malfunction is one which may cause a hazard under the circumstances described above. For purposes of clarity, malfunctions do not include accidents and incidents resulting from negligence, malpractice, or implication in such situations as vehicular accidents, fires, and so on. However, malfunctions do include abnormal or premature function of explosive ammunition items during normal handling, maintenance, storage, transportation, and tactical deployment. Includes cook off, hangfire, misfire, and so on.

Nonexpendable item

Items which are not consumed in use, keep their original identity during the period of use, and require that accountability be maintained throughout the life of the item.

Organization clothing and equipment record

A form used to record military-type clothing for which the organization commander is responsible. It is rotated among using individuals as required.

Organizational-level repairs

Repairs authorized for the performance of maintenance at the organizational level.

Post

To make all the required entries on a document; for example, to post transactions to the property book.

Property book

A record book kept in a unit to control all nonexpendable property of the unit. The property book contains a record of all tables of organization and equipment, tables of distribution and allowances, and common tables of allowances items. Items of individual clothing and equipment are not recorded in the property book.

Serviceability code

See condition code.

Soldier's Manual

An STP listing of critical tasks for each SL in a particular MOS.

Status cards

Data cards sent from the supply source to the requester providing current information on due-in supply requests.

Summary of issue/turn-in

A document used to post an increase or a decrease of organization clothing and equipment to the property book.

Supply support activity (SSA)

An activity that processes selected items of supplies and equipment for organizations and units within its area of responsibility.

Turn-in document

A form used to turn in supplies and equipment to the SSA.

Verify

To prove the truth of a supply transaction.
