

PARA 1-13	REDUCTION IN GRADE	When a SM is discharged with OTH the SEP AUTH will direct an immediate reduction to the lowest enlisted grade per AR 600-8-19, Chapter 10
PARA 1-16c	REHABILITATION	<p>TRAINEES - will be recycled at least once</p> <p>SOLDIERS - not in a training status will be locally reassigned at least once, with a minimum of 3 months of duty in each unit. Reassignment should be between battalion-sized (or larger) units</p> <p>PCS - Meritorious cases may warrant PCS</p>
PARA 1-16d	REHAB WAIVER	<p>Waiver of counseling not authorized</p> <p>11, 13, 14 may be waived by SEP AUTH if:</p> <p>Two APFT Failures; Pregnancy in ELS; Highly disruptive or potentially suicidal behaviour; active resistance of rehabilitative efforts; Soldiers assigned to small or remote locations; detrimental to the Army or Soldier (indebtedness, ASAP, AWCP etc);</p>

PARA 1-18	SUSPENSION	EXCEPT for Fraudulent entry or homosexual conduct, execution of an approved separation is authorized not to EXCEED 12 months - it may only be executed if the Soldier engages in conduct similar to that for which separation was approved
PARA 1-47	BARS TO REENLISTMENT	IF a commander does not lift a bar to reenlistment upon the second review the commander WILL initiate separation under Ch 13, 14 or appropriate chapter of this regulation for the underlying reason for the bar - not the bar in and of itself
